1. Approve Systemwide FY24 Operating and Capital Budgets

MOVED, on recommendation of the Financial Affairs Committee, that the Board of Trustees, approve operating budgets and capital budgets, for the University System applicable to the fiscal year beginning July 1, 2023, and ending June 30, 2024 (FY24) as presented in the attachments;

AND FURTHER delegate authority to the Chief Administrative Officer, in consultation with the Presidents'

Council and the Chair of FAC, to approve adjustments to the FY24 budget as presented to reflect the

final State budget (operating and capital) approved for FY24; AND further delegate authority to the Chief

Administrative Officer to make any further necessary adjustments to comply with generally accepted accounting principles prescribed by the Governmental Accounting Standards Board (GASB) for FY24.

2. Thermal Project

MOVED, on recommendation of the Investment and Capital Planning Committee, that the Board of Trustee approve a project budget not to exceed \$11.2 million dollars for the Thermal Energy Storage Tank project with source of funds intended to be \$6.8 million in UNH operating reserves, \$1.15 in federal grant, and \$3.25 in investment tax credit, AND FURTHER UNH funds will be used, as needed, in advance of receiving the grants and tax credits. In the event the anticipated grants and tax credits are not received, the shortfall will be covered by UNH funds within their authorized capital budget.
